Privacy Policy

We are aware that both you and we care about the information we collect, and we encourage you to read the following privacy policy to learn how and for what purposes we collect your data.

All personal information is provided only when it is necessary for the use of the services offered by fair and lawful means, with your full knowledge and consent. Data is encrypted during transmission via a secure https connection.

DozaBot administrators do not share or sell your personal information for advertising or marketing purposes. In addition, we do not share your personally identifiable information with other third parties unless required to do so by law or by a government institution.

The following information is collected by DozaBot's services only for their proper functioning:

- Guild ID Stored only in certain circumstances for information such as server configuration for moderation and level commands;
- Channel ID For using commands and saving configurations that are channel specific;
- Member ID To link you and your server members with saved configurations;
- Messages Content For message specific features such as reaction roles, reaction checking, welcome and goodbye messages from the server, message counting and commands using a custom description;
- Date & Time To display user or server specific information for some commands available on the bot (example: /stats);
- Emojies To display custom emoji for Giveaway category.
- Number of Messages For counting messages sent to the server and providing detailed information for some commands available on the bot (example: /stats);
- Voice Time For counting time spent on a voice channel and providing detailed information for some commands available on the bot (example: /stats);

• Info About Invites & Invites Links – For counting the number of people invited to a given server or the number of invitation links created.

We keep the information collected only as long as necessary to provide you with the service you requested. The data we collect, we will protect using commercially reasonable means to prevent loss and theft, as well as unauthorized access, disclosure, copying, use or modification.

Our Service or Site may contain links to other external sites that are not operated by us. Please be aware that we have no control over the content and practices of these sites and cannot assume responsibility or liability for their privacy policies.

You can always choose not to disclose information to us, but please note that you may need to provide us with certain information in order to take advantage of some of our services and features.

You can ask us for information about the personal data we hold about you, including information about what categories of data, what it is used for, where we collected it from. You can obtain a copy from us, free of charge, containing the personal data we hold about you using the email address mentioned at the end of the document.

We will try to resolve your request within a maximum of 30 calendar days. However, the period may be extended for reasons of specific legal right or complexity of the request.

- ✓ Personal data were collected and processed unlawfully;
- \checkmark You withdraw your consent on the basis of which the collection takes place.
